



Eyes for Ewe Border Collies Stud Service Contract for
CH Peachykeens Standing Ovation CD RN

Thank you for expressing an interest in using Bravo in your breeding program. Before a commitment for breeding is made, please consider the following. Prior to a breeding agreement, I require from you:

1. A photocopy of your bitch's registration
2. A four generation pedigree
3. A photocopy of your bitch's OFA rating, CERF exam and results of DNA CEA test

Following an agreement to breed, it is required that you:

1. Send a copy of your bitch's current negative Brucellosis results reported within 14 days of the expected breeding.
2. Pay all veterinary costs, at the time of the service, while the bitch is in my care. This would include vaginal smears, progesterone tests as well as artificial inseminations (if the bitch or stud dog is not able to perform a natural (tie) breeding.)
3. Pay all expenses if using fresh chilled semen including collection kits, semen collection, shipping charges, etc.
4. Pay all transportation costs for the bitch.
5. Pay boarding fees of \$15 per day for any extended stay beyond the 4 days included with the breeding days.
6. Provide a record of current vaccinations including rabies.
7. Register all puppies under the Limited Registration with the exception of the puppy/puppies kept intact by the Breeder (owner of bitch) and/or the owner of the Stud Dog unless agreed upon otherwise by stud owner prior to selling of puppies.
8. Sell all puppies not owned by breeder or stud dog owner with a spay/neuter contract unless agreed upon otherwise prior to selling of puppies.
9. Have all puppies examined by a certified Ophthalmologist between 6 and 8 weeks of age with a copy of each puppy's eye exam sent to owner of stud dog.

Prior to an agreement to breed, my responsibilities to you are as follows:

1. Provide a copy of Bravo's registration.
2. Provide a copy of Bravo's OFA rating, current CERF exam and copy Optigen CEA DNA results.
3. Provide a 4 generation pedigree

Following an agreement to breed, it is my responsibility to:

1. Provide a copy of Bravo's current negative Brucellosis results within 14 days of the expected breeding.

1. The stud fee for Bravo is \$ _____ OR 1st pick puppy. Decision whether to take pick puppy or stud fee will be made on or before the puppies turn 8 weeks old.
 2. If the stud dog owner decides to take the stud fee, the balance is payable in full before the stud dog owner will sign the litter registration application.
 3. If the stud dog owner chooses to take a puppy as stud fee, the prefix Eyes for Ewe will come first in the registration name.
 4. If a breeding does not occur, either naturally or artificially, after this agreement has been signed, the owner of the stud dog will return the stud fee minus any incurred expenses. This is applicable only if said bitch has not been delivered to stud dog owner for any attempts at providing a stud service and money was paid.
 5. If the bitch whelps one (1) live puppy, a balance of \$ _____ is due before registration paperwork is signed.

A guarantee of actual mating only is made, and not of pregnancy or of puppies living or dead.
